



6 Community Action 60 Years int commit

On January 8, 1964, President Lyndon B. Johnson called on Congress to do something never before done: set an aim not only to relieve the symptom of poverty, but to cure it and, above all, to prevent it. Johnson acknowledged in his State of the Union Address that no single piece of legislation would suffice. With Johnson's declaration of a War on Poverty and the various pieces of legislation that came after, the administration and Congress acknowledged the complexities of poverty, and the intertwined nature of poverty with racial discrimination, and made a commitment to do better across a wide range of issues for all Americans.

In May of 1964, in a speech to University of Michigan graduates, Johnson declared America had the wealth and the power to build the Great Society: "The Great Society rests on abundance and liberty for all. It demands an end to poverty and racial injustice to which we are totally committed in our time." To achieve the vision of the Great Society, an unprecedented number of bills were enacted-bills addressing civil

rights, jobs and economic development, education, training, health, housing, enlarging youth opportunities, and assisting the aged and disabled. Additional pieces of legislation addressing the environment, transportation, consumer protection, and arts and culture were also passed.

On August 20, 1964, President Johnson signed the Economic Opportunity Act (EOA). While the EOA was not the only anti-poverty legislation, it is often seen as the cornerstone of the War on Poverty. The EOA included several titles that created new programs, including Title II, which created Rural and Urban Community Action Programs. Other components of the EOA included programs such as Job Corps, Adult Basic Education, Neighborhood Youth Corps, Senior Community Services Employment, Upward Bound, Volunteers in Service to America (VISTA), and Migrant and Seasonal Farmworker. The same year, in Hayter's Gap, located in rural southwest Virginia, a school principal, a general store owner, his school librarian wife, and other community leaders formed the Hayter's Gap Community Club to provide education, recreation, and daycare for local residents. By December 1964 the club expanded in scope when it was approved for funding by the federal Office of Economic Opportunity (OEO), recently created under the EOA. The club was renamed the Progressive Community Club and was chartered as one of the nation's first Community Action Agencies (CAA) designated to serve economically disadvantaged community members throughout Washington County and the City of Bristol. That grassroots local coalition has grown to become People Incorporated, one of the most innovative CAAs in the nation.

Just as in Hayter's Gap, local coalitions of local people across the country used EOA funding to establish CAAs. OEO awarded the first Community Action grants in November 1964. CAAs were established at breakneck speed; by 1966 1,600 new CAAs, serving people in urban and rural areas, on Tribal lands, and in migrant seasonal farm communities across America had been established.

As CAAs were created at different times–with some perhaps as early as November 1964, and others many years later– individual CAAs and State Associations will celebrate their 60th anniversaries in 2025 and beyond.

As we acknowledge 60 years of Community Action in America, we urge you to stay tuned for 2028 as we celebrate 60 years that Community Action Agency of St. Louis County has been a part of this phenomenal 1000 agency network!

40,616 Individuals with low incomes received assistance to stabilize their households.

EMERGENCY ASSISTANCE

13,832 Employment and education support services designed to reduce or eliminate barriers to initial or continuous employment and educational attainment were delivered.

1,377 Individuals, including infants, youth, parents, and other family members benefited from participation and received case management and family development support to help them to achieve their goals.

32,208 individuals received emergency assistance payments to restore utilities, prevent disconnects and prevent evictions and foreclosures.

3,057 individuals received emergency services such as food, counseling, and referrals.

3,735 Individuals received the opportunity to engage in community and advocacy activities that helped to improve, support, and promote community and individual well-being.

\$254,442 was paid out to vendors to prevent homelessness for 156 households.



JOURNEY AWARD DARRYL "PEEWEE" LENARD

Coach Darryl "Peewee" Lenard is a beloved figure on the basketball courts of St. Louis, having dedicated over 30 years to the game. From his early days as a toddler chasing older siblings, to his current role as a devoted coach, Coach Lenard has used the simple game of basketball to mentor and prepare kids for the challenges of life.

Coach Lenard rose to national prominence as a standout point guard with the Central High School Redwings, where he earned recognition as a Street

& Smith's first-team high school All-American. His impressive high school career also included two selections to the *St. Louis Post-Dispatch* All-Metro First Team and All-Missouri Team. A dynamic player, Lenard averaged 25 points per game while leading his team in assists and steals during his junior and senior seasons. This dynamic team packed gyms throughout the region as they averaged over 105 points per game without a 3-point line, making high school basketball history. To date, no other team has achieved this tremendous feat in a 32-minute game, even with a 3-point line!

After high school, Lenard accepted a scholarship to the University of Georgia before transferring to St. Louis University under Coach Rich Majerus's guidance. As a Billiken, he left his mark as the all-time leading free-throw shooter with an 86% average and ranked fifth all-time for career steals.

Transitioning into coaching, Coach Lenard has spent the last 15 years with the Bradley Beal Elite basketball club, where his leadership has been instrumental in the program's success. Under his guidance, the BBE teams have secured multiple championships and produced numerous NCAA and NBA players and coaches. (See sidebar.)

Basketball is more than just a game to Coach Lenard; it is a vehicle for teaching valuable life lessons. His coaching philosophy centers on instilling qualities such as commitment, sportsmanship, character, pride, and selflessness in his players. Through his dedication and mentorship, Coach Lenard strives to cultivate a sense of pride, humility, and respect in the youth he works with, ensuring they are prepared for success both on and off the court. For Lenard, basketball has always been more than a game.

JAMES E. WILLIAMS, JR. **BUSINESS LEADER IN ACTION AWARD**



James E. Williams, Jr. is founder, president, and chief executive officer of Estel Foods Inc., which owns and operates 25 McDonald's restaurants in the St. Louis metropolitan area. As an operator of one of the world's most recognized brands, Williams has come full circle in his employment history; as a teenager, he worked at McDonald's.

Known for working seven days per week and maintaining an active role in all parts of the business, Williams relishes his engagement with the company's corporate entity, while ensuring that local operations are sound and efficient. Employee development and customer satisfaction are priorities in his operations.

Williams began his business career with McDonald's in 1998 with a single store in Granite City, Illinois, and grew his business one store at a time before acquiring multiple stores in 2014. Estel Foods Inc. has headquarters in East St. Louis, Illinois, Williams' hometown.

Before becoming a McDonald's owner-operator, Williams served nine years with the U.S. Navy, where he clocked more than 2,000 flight hours in various countries around the world. Williams was recognized for his military service and earned the U.S. Navy Achievement Award. He credits his Navy experience as key to business success, most notably the concept of teamwork.

Williams serves as an executive board member and president of the African American consumer market division for the St. Louis McDonald's Co-op, a collaborative of local franchise owners. He serves on several community boards, including the Ronald McDonald House, Lessie Bates Davis Neighborhood House, One Hundred Black Men of St. Louis, Granite City Rotary Club, Granite City Chamber of Commerce, St. Louis Downtown Partnership, U.S. Veterans. Williams is also a board member of the St. Louis Zoo, St. Louis Children's Hospital, The Nine Network, Regional Business Journal, Concordance Academy, Paramount Bank, and supports, and is involved with, the renowned Jackie Joyner Kersee Foundation.

Susan Warren, 55-year-old entrepreneur, homeowner, and educated woman with disabilities, is a proud two-time winner of the Volunteer of the Year Award. In 2023, she received a degree in Culinary Arts; in December 2025 she expects to earn another in Baking and Pastry from St. Louis Community College.

In 2024, Susan launched "SUE LOUs and Suzi Qs, LLC" where she creates shelfstable baked goods and specializes in dog and cat treats. She believes that her disabilities are opportunities to defeat the odds and plans to obtain a food truck to produce and sell great products in service of the St. Louis community.

She has received certificates from CAASTLC's Entrepreneurship Class and Step Up to Leadership programs. A grant from Step Up to Leadership will enable her to deliver goods to families in St. Louis County this holiday season.

Susan enjoys volunteering at CAASTLC and notes that collaborating with the staff and clients helps sharpen her customer and human service skills.

DR. KRISTY JACKSON COMMUNITY PARTNER AWARD



Kristy Jackson, Ed.S., is a dynamic leader whose combination of entrepreneurial and education experience makes her the perfect fit as the founding Executive Director of the Center of Innovation and Entrepreneurship (CIE) at Harris-Stowe State University's Anheuser-Busch School of Business. At the CIE, she leads innovation and the facilitation of partnerships to enhance Black and Brown scholars as well as St. Louis community members. In the start-up year of the CIE, she launched new entrepreneurial programs including two early-stage incubators, MECCA and a facilitator training program.

The CIE is an extension of the Anheuser-Busch School of Business and the vision of Dr. Stacy Gee Hollins, Interim Associate Provost of Academic Affairs and Dean. 
